Service category: Adult Day Health Care AIDS- provides specialized services for registrants with AIDS (acquired immune deficiency syndrome), and other human immunodeficiency virus (HIV) related illness.

Service category: Clinical Laboratory - provides microbiological, immunological, chemical, hematological, biophysical, cytological, pathological, genetic or other examination of materials derived from the human body, for the purpose of obtaining information for the diagnosis, prevention or treatment of disease, or the assessment of a health condition, or for identification purposes.

LTS

Service category: Limited Transfusion Services - facility which transfuses blood and may temporarily store blood and distribute it within its own organization, but relies on a blood bank holding a permit in blood services-transfusion to perform laboratory tests.

Respite

Service category: Respite Care Services. (Short Term) - scheduled short term nursing home care provided on a temporary basis to an individual who needs this level of care, but who is normally cared for in the community.

Ventilator

Service category: Ventilator Dependent - serves long-term ventilator dependent residents.

OPOT

Service category: Outpatient Occupational Therapy - instructing patients in prescribed academic subjects to prevent mental deconditioning, improving patients' mental and physical conditions and aiding in the attainment of knowledge and

skills that will further residents' progress toward vocational objectives.

OPPT

Service category: Outpatient Physical Therapy - employs therapeutic exercises and massage and utilizing effective properties of heat, light, cold water and electricity for diagnosis and rehabilitation of patients with neuromuscular, orthopedic and other impairments.

OPSP

Service category: Outpatient Speech Pathology - rehabilitation services.
